#### **Trainee Enrolment**

For a company (or an individual) to register someone (e.g. a new employee) as a trainee the company (or the individual) must complete an enrolment form, within 6 months of commencing employment and pay the inclusive enrolment fee of £290. This fee includes the Training Manual and the first Examination fee\*. which includes the first two years of enrolment until (they pass their exam) after which they will pay the annual fee of £54 per year.

The trainee is then required to attempt the examination within 2 years of the commencement of employment and pass within 3 years.

\*In the event of a candidate failing the first sitting of the examination candidates will be required to pay a re-sit fee of £180.

NOAH reserves the right to review the enrolment fees and associated costs of the training manual and examinations.

#### **Registration for examinations**

Applications to take examinations must be made to directly to Harper Adams (university commissioned by NOAH to handle the examination). Only those properly enrolled with NOAH may take the NCAH examination. The forms can be accessed via the NOAH website.

#### **Despatch of Certificates**

A list of results of each examination will be sent to NOAH. Certificates will then be issued as soon as possible to the student's by email.

Provided NOAH is satisfied about the identity of the person asking, NOAH will advise the student of his or her result by email.

Results will be given to an employer of an examinee unless the candidate has indicated that they do not

wish for their results to be released to their employer by ticking the appropriate box on the enrolment form or by providing NOAH with other written permission.

#### **M Numbers**
